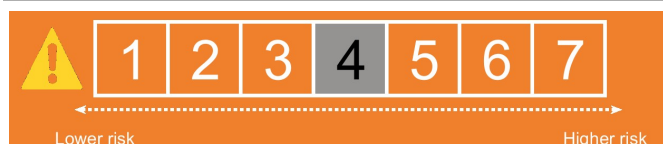

## What are the risks and what could you get in return?

## What happens if FundRock Management Company S.A. is unable to pay out?

## What are the costs?

### Table 1: Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. - In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
